Since 2008 God has enabled the **DBC Life Trust** to give towards the ongoing needs of many of our retired pastors and missionaries, including their spouses. Over this period the numbers we support have fluctuated, sometimes adding people when we discover someone else who has been living with trying circumstances. We have also removed people when, sadly, they have passed away. We give R600 per month and, with God's help, we

have never been in a position where we have had to stop our support owing to a lack of funds. Presently we support 39 individuals and couples. This is an immense privilege for us as trustees and we both thank those that have contributed and invite others to do the same. This is meeting real needs in a responsible manner that not only sees God glorified but also people being loved in a practical, caring manner.

There are **TEN STUDENTS**, who came through the Homework club, that are busy with their tertiary studies.


